

# **Abstract Submission Guidelines**

The European Navigation Conference 2026 invites academics, technicians, policy makers and other stakeholders to submit an abstract. The online abstract submission portal is open.

The deadline for abstract submission is **15 December 2025.** Please note that only electronic submissions are accepted.

# **Abstracts Requirements**

Abstracts should meet all of the following specifications in order to be considered for scheduling:

### Language

Abstracts should be written in English. We kindly ask you to proofread abstracts carefully to avoid errors before they are submitted.

#### Title

Each abstract should have a brief descriptive title of maximally 15 words and should be written in sentence case.

### **Presentation type**

During the abstract submission process, you will be asked to indicate whether you wish to give an oral presentation of a poster presentation.

### **Topics**

During the abstract submission process, you will be asked to select a topic for your abstract from the list below. Select the abstract topic matching the content of your abstract best. If none of the pre-specified topics applies to your abstract, select 'Open Session'.

## <u>Authors</u>

Names, affiliations, cities, and countries of all contributing authors should be provided. The person submitting the abstract should be the presenting author of the work. All communications regarding an abstract will go to the submitting author, irrespective of the designation of the presenting author. Please verify that your email address is correct as it will be used for contacting you after the review process.

#### <u>Text</u>

Please limit abstracts to 200 – 500 words and define abbreviations when first introduced.

## **Abstracts Deadlines**

- Abstract Submission Deadline: 15 December 2025
- Notification on Acceptance/Rejection: early February 2026
- Early Bird Registration Deadline: end February 2026
- Programme Schedule Notifications: early March 2026
- Full Paper Submission Deadline: early May 2026

## **Review and Acceptance**

Submitted abstracts will undergo review by the technical scientific committee and will be scheduled for presentation at ENC 2026 only if accepted by the reviewers. **Abstract will be reviewed as received, so please do not wait until the deadline to submit your abstract.** 

Scheduling notifications will be sent to the submitting authors around early March 2026.

To ensure scheduling of a submitted and accepted abstract in the final ENC 2026 programme, the presenting author must be registered as an ENC 2026 delegate by end February 2026. ENC 2026 will not cover costs incurred in submitting an oral or poster presentation, or for travel and accommodation costs for presenting authors. Failure to register for ENC 2026 by the set deadline will lead to the withdrawal of your abstract(s).

Withdrawal of abstracts can only be accepted if notified in writing and subsequently confirmed by the ENC 2026 Conference Secretariat.

# **Full Paper Submission**

Authors of accepted abstracts have the option to submit a full paper. The deadline for full paper submission will be early May 2026.

Note that submission of a full paper is not required for presentation at the conference, but papers submitted for publication will only enter peer review if presented at the conference. For posters, one of the authors must present it during the Poster Session.

Submissions are limited to scientific (research) papers. All submitted papers will undergo a further peer review process.

### **Publication Policy**

Accepted papers will be published in a dedicated volume of the Open Access journal Engineering Proceedings (ISSN 2673-4591) and in the Conference Proceedings e-Book (with ISBN), both published by MDPI. The Creative Commons CC BY 4.0 license will apply, meaning that authors retain copyright and the content can be reused with attribution. All published papers will be assigned a digital object identifier (DOI) and citable.

#### **General Paper Guidelines**

Papers should cover high-quality scientific work and create an advance towards the current knowledge that is of interest to the scientific community. Papers should not have been previously published or submitted elsewhere. Papers must be original and include references where appropriate. Specialized software will be applied to identify potential plagiarism, including self-plagiarism.

In case a paper is deemed to be of a commercial nature only, the conference organizers reserve the right to reject the paper.

# **Formatting Guidelines**

Papers should be written in clear English language (MDPI publishes in US English). Paper length must be between 4 and 9 pages. Note that this refers to the total page count (including abstract, references, appendices, etc.). The paper length requirement must be strictly complied with.

#### **Paper Reviews**

All submitted papers will undergo a further peer review process. Authors who choose to submit a full paper will be invited to review a manuscript within their area of expertise.
