Spectrum QC eco™ is made with an 80% bio-based plastic shell using the mass balance approach, certified by International Sustainability and Carbon Certification (ISCC) PLUS.<sup>1</sup> The bio-based materials have a 74% lower carbon footprint than fossil fuel-based alternatives.<sup>2</sup> This is accomplished without compromising performance.
