WORKSHOP OVERVIEW

ADVANCING KNOWLEDGE AND COLLABORATION ON MATURE AND EMERGING PETROLEUM SYSTEMS

Building on the success of the inaugural event, the second edition of this conference will continue to focus on the transformative discoveries in the Guyanese, Surinamese offshore, and adjacent areas. From Liza to Uaru, Hammerhead to Jethro and Carapa in Guyana, and Maka in Suriname, the continued exploration and appraisal activities have revealed oil-prone petroleum systems across at least three distinct plays in the deep-water province stretching from Eastern Venezuela to Suriname. These discoveries, while still in their early stages, have unlocked valuable insights into the region's hydrocarbon potential. However, much of the knowledge remains within the commercial realm, awaiting opportunities for broader dissemination and collaborative development.

This conference aims to foster a dynamic environment that brings together key stakeholders from exploration and production (E&P), technical vendors, and government agencies. Through focused discussions and knowledge-sharing sessions, participants will explore initial results, technological advancements, and future prospects for the region. By sharing expertise within the constraints of data confidentiality, operators and technical experts can collaboratively address critical themes, share best practices, and discuss the challenges of deep-water exploration, appraisal, and development. Contributions from regions such as the Gulf of Guinea, Columbus Basin, and Eastern Venezuelan Basin—where petroleum systems are more mature—will further enrich discussions by providing valuable analogues and lessons applicable to the emerging Guyanese margin.

The technical program will emphasize the region's complex sedimentary systems, which span from Eastern Venezuela to French Guiana. These systems are shaped by three primary fluvio-deltaic entry points that have evolved over geological time: (1) the Aptian Demerara system, (2) the Upper Cretaceous Berbice system, and (3) the Miocene-Pliocene Amazon system. These systems have deposited extensive sand-prone paralic-shelfal formations that have charged diverse deep-water settings, including intra-slope ponded systems, channelized slopes, mass-transport complexes, and basin-floor frontal splays. Understanding these varied depositional environments is crucial for advancing exploration and development efforts.

This second edition will feature an engaging single-track format over three days, including technical presentations, poster discussions, and thematic workshops. Participants will benefit from the latest insights into the region's hydrocarbon potential, geological settings, and technological advancements. We invite presenters to submit talk titles and concise (200-word) abstracts summarizing their proposed contributions to help the technical committee design a robust and relevant agenda that addresses the key challenges and opportunities in this evolving frontier.

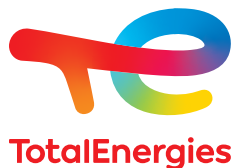
