Terms and Conditions

Thank you for registering for this Health Information and Management Systems ("HIMSS") program ("Event"). The following Terms and Conditions ("Terms and Conditions" or "Terms") apply to you and your participation in the Event. By registering for the Event, you agree to these Terms, so please read them carefully. Failure to comply with any of the Terms may result in registration cancellation without refund. HIMSS reserves the right to expel anyone from the event who does not comply with any of the policies, in HIMSS's sole discretion.

Registration Rates

The Early Bird registration rate only applies to registrations with payment received by July 19, 2024 at 11:59 PM ET. Registrations made after this date will be charged the Advanced or On-Site rate. Confirmations will be sent via email. If you do not receive a confirmation email within 24 hours of submitting your registration, please notify us at EventRegistration@himss.org.

Please note: If you register under an incorrect fee category, HIMSS reserves the right to shift your registration to the correct category and charge the updated amount to the original payment method on file.

Badge Rules

Bring your government identification to the Event. Each registrant will be issued a badge onsite and is required to wear it at all times during the Event and any related organized functions. Exchanging badges with any other person is strictly prohibited. Anyone discovered wearing a badge that does not match their identification will be ejected from the Event without a refund at the discretion of the Event organizers.

Code of Conduct

Cancellation Policy

Registration cancellations must be submitted in writing via email to Event Registration@himss.org. Registration cancellations by telephone are not accepted. Canceled registrations received two (2) weeks prior to the Event (September 6, 2024) will be refunded, less a \$100 administrative fee. Canceled registrations received after this date are not refundable. Refunds will be processed within 90 days of receiving the cancellation notice. Reinstatement of registration is not permitted after cancellation has been processed by HIMSS.

Attendee Substitutions

Please email your substitution request, along with a completed registration form for the substitute attendee, to EventRegistration@himss.org. Requests must be received no later than September 6, 2024. Substitute attendees must be of the same registration type as the original attendee. HIMSS reserves the right to decline substitution request for any reason.

HIMSS Cancellation or Modification

HIMSS reserves the right to cancel, modify, or reschedule the Event for any reason, with all such decisions being at HIMSS's sole discretion. If HIMSS cancels the Event, HIMSS will automatically apply any pre-paid portion of your registration fee toward registration for the next HIMSS event located in the United States and occurring within twelve (12) months of the date of the Event, excluding the HIMSS Global Health Conference & Exhibition. Such application of your registration fee to a subsequent event shall be your sole remedy in the event of cancellation of the Event. HIMSS is not responsible for any expenses or costs registrants may incur in planning to attend the Event. Registrants who purchase non-refundable transportation and/or lodging do so at their own risk.
