### PAYMENT OF REGISTRATION FEES

Full payment must be made by credit/debit card at the time of registering. Cards accepted are Visa, Visa Debit and MasterCard. Unfortunately, we cannot accept American Express, Visa Purchasing or Maestro.

You will not gain access to the conference unless full payment has been received.
