
# **The State Statistics Service of Ukraine**

(hereinafter, the **SSSU**) produces and disseminates official statistics in accordance with the basic principles of official statistics

**2010** - Basic principles of activity of the state statistics bodies according to the European Statistics Code of Practice, 2005

 2018 - Principles of activity of the state statistics bodies in accordance with the amendments to the European Statistics
Code of Practice, 2017

**2022** - Law of Ukraine «On Official Statistics» Article 4 «Basic principles of official statistics»





# Law of Ukraine «On Official Statistics»

approved 16.08.2022 by № 2524-IX https://zakon.rada.gov.ua/laws/show/2524-20#Text

Article 4 «Basic principles of official statistics» includes all principles of the European Statistics Code of Practice

### **Chapter VII Quality of official statistics**

**Article 35 «Obligations to ensure quality»** Producers of official statistics are obliged to continuously assess and improve the quality of official state statistical information and document in a standard way the data sources and methods used to produce official state statistical information

Article 36 «Assessment of the quality of official state statistical information» producers of official statistics assess the quality of official state statistical information by conducting consultations with users and respondents with the involvement of scientists, experts and international organizations



### **Program to develop official statistics until 2028**

approved by Resolution No. 989 of the Cabinet of Ministers of Ukraine dated on September 15, 2022

### **Priority areas of development:**

- Harmonize the national statistical system with international and European norms and standards;
- Digital transformation;
- Openness and availability of information.

### Action plan to implement the Program

implementation of Commission Recommendation (EU) No. 2023/397 of February 17, 2023 regarding statistical standards of data and metadata.

**Quality reports** based on the European standard Single Integrated Metadata Structure **(SIMS)** 

- **2023** preparation has started, 29 quality reports have been prepared
- **2026** quality reports are prepared for all state statistical observations

# **Documentation of the SSSU Quality Management System**

### The SSSU makes use of the National Activity Model to:

- Form the Technological Program of the State Statistical Observations;
- Analyze data of the Automated system of accounting for working time spent;
- Form the SSSU Activity Plan;
- Implement risk identification and assessment;
- Prepare the activity report;
- Make an inventory of the state statistical observations;
- Implement other activities

# **Commission for Coordination of Quality Management Activities of the SSSU**

The SSSU permanent advisory body

The Commission composition includes the representatives of 10 SSSU functional and sectoral divisions.

As part of the SSSU planning, development and international cooperation department, the division for statistical activity **quality assurance is functioning**.

**2022** – The Questionnaire has been used to prepare the action plan for the Program to Develop the Official Statistics until 2028.

Members of the national statistical system participate in the **inventory of the state** statistical observations.

**The working group on making the inventory** considers the issue related to compliance of the methodology for compilation of data from the state statistical observations with the the European Union aquis.

# Action Plan to implement the European Commission recommendations

For the Ukraine's Progress Report within the framework of the 2023 EU Enlargement Package

Implement the measures aimed at strengthening the institutional and administrative capacity of the SSSU, informing the Cabinet of Ministers of Ukraine about the results of their implementation;



Increase the production and timely transfer of quality data to Eurostat.

### SSSU measures to increase production of data transmission to Eurostat

- Improve the methodology of statistical data compilation in accordance with the European norms and standards;
- Get familiar with the list of indicators and tools for data transmission to Eurostat;
- Prepare the draft Law on amendments to the current legislation, according to which the respondents will be required to submit reports to the state statistics bodies during the period of martial law.
