

Essential Tickets Terms & Conditions

Your Contract

- **1**. Essential Tickets have been authorised by Spring Harvest (Event Organiser) to sell tickets for their event.
- 2. The sale of your ticket is subject to policies set forth by the Event Organiser.
- **3.** By making a booking you enter into a direct contract with the Event Organiser. We act solely as agent of the Organiser and are not responsible for any loss, injury or damage whatsoever caused except where any such loss, injury or damage to you is caused by our negligence.

Your Ticket

- **4**. Your ticket remains the property of the Event Organiser and may be withdrawn and admission refused at any time upon refunding the printed purchase price.
- **5**. Once purchased, tickets cannot be returned, refunded, exchanged or transferred, unless the event is cancelled or moved to another date.
- **6.** When you place your order you agree that the tickets are for the personal use of you and your party only, and will not be resold or transferred. Any attempt to resell the tickets will result in your orders being cancelled without prior notification.
- **7**. In order to prevent fraud and to protect both parties, you may be asked to provide additional information after your booking so that we can verify your purchase.
- **8**. A limited number of tickets are available for sale. Therefore, some types of ticket may sell out quickly. We reserve the right to cancel your ticket should we find that certain types of tickets are oversold. In these circumstances, a full refund including the booking fee will be provided or alternatively a suitable alternative will be offered. Tickets may not be available on the door.
- **9**. It is your responsibility to check your tickets as mistakes cannot always be rectified. If there is a problem with your tickets, please contact the Event Organiser using the contact details provided on the event page. Essential Tickets act solely as an agent for the Event Organiser and are unable to enter into any correspondence.
- 10. We will not be responsible for any tickets that are lost or stolen.
- **11.** Tickets are sold subject to the venue or Event Organiser's right to alter or vary the programme due to events or circumstances beyond their reasonable control without being obliged to refund monies or exchange tickets.
- **12**. Tickets purchased from Essential Tickets will be subject to a booking fee. The booking fee covers credit card charges and admin costs incurred by Essential Tickets. The Event Organiser does not benefit from this booking fee.

13. Only the cardholder can present the credit or debit card used to make payment and sign a receipt. This is part of the credit card merchant agreement and is in place to protect both us and the cardholder from potential credit card fraud.

E-tickets for Individuals and Groups.

14. Essential Tickets will deliver all ticket orders electronically, via an e-ticket email that will include all booking information. You will need to print and present your e-ticket on the door.

Cancellations, Changes and Refunds

- **15.** Occasionally, events are cancelled or postponed by the promoter, performer or venue for a variety of reasons. If the event is cancelled, then the face value of your ticket may be refundable, but your booking fee will not be refundable.
- **16**. Neither the venue, the Event Organiser nor Essential Tickets shall have any further liability beyond the face value of the ticket purchased.
- **17.** It is your responsibility to ascertain whether an event has been cancelled and the date and time of any rearranged event. If an event is cancelled or rescheduled, Essential Tickets will promptly notify ticket holders via email and update the event page as soon as confirmation is received from the Event Organiser.
- **18**. We do not guarantee that ticket holders will be informed of such cancellation before the date of the event
- 19. In the event of cancellation refund restrictions may apply, as set by the Event Organiser.
- **20**. If the event is cancelled, ticket holders should contact the Event Organiser for details of rescheduled events or refunds (if applicable). It is entirely at the discretion of the Event Organiser whether they offer refunds and all correspondence relating to cancellations and/or refunds should be direct with the Event Organiser.

Right to Admission

- **21.** Your ticket is issued subject to the Rules and Regulations of the venue and Event Organiser. Full details should be available on request from the Event Organiser. Breach of any of these Rules and Regulations or any unacceptable behaviour, nuisance or injury shall entitle the venue or Event Organiser to eject you from the venue.
- 22. The right to admission to an event is reserved by the promoter and event venue, who may take health and safety, environmental and security concerns into account at their discretion, and may on occasion carry out security searches. We would advise you that no refunds will be offered to customers who are refused entry or ejected from a venue on account of late arrival, being (or appearing to be) under age where an age limit has been advertised, declining to be searched, abusive, threatening, drunken or other anti-social behaviour (including smoking in no smoking areas), carrying offensive weapons or illegal substances, or making unauthorised audio, video or photographic recordings.

Booking Fees

- **25**. Booking fees are non-refundable under any circumstances other than those detailed in clause 8
- **26.** In accordance with UK consumer protection laws, all mandatory fees including booking and admin fees are included in the headline ticket price. These fees are non-refundable except in cases of ticket overselling (see Clause 8). Essential Tickets confirms that all advertised prices include these mandatory fees.

Disabled Bookers

- **27**. Please contact the Event Organiser for details of concessions for people with disabilities or their carers.
- **28**. The Event Organiser may require you to provide documentation to show your status as carer such as evidence of Carer's Allowance or Disability Living Allowance.
