### **Your Contract**

### **Your Event Log-in Details**

4. Your personal log-in details which will be emailed prior to the event remain the property of the Event Organiser and may be withdrawn and participation refused at any time.
5. Your personal log-in details are for the personal use of you and your party only and will not be transferred.
6. It is your responsibility to ensure your log-in details are working. If there is a problem with your please contact the Event Organiser using the contact details provided on the event page. Essential Event Management act solely as an agent for the Event Organiser and are unable to enter any correspondence.
7. Registration is subject to the Event Organiser's right to alter, vary or cancel the programme due to events or circumstances beyond their reasonable control
8. Neither the venue, the Event Organiser nor Essential Event Management shall have any further liability beyond the value of the registration £0.
