Please identify the presenting author by clicking the 'Presenter' field in the appropriate box. A maximum of 2 presenting authors are allowed.

Preparation of your Paper for submission

- 1. A brief abstract (maximum 250 words) must be entered into the text box
- 2. A document in the form of either a paper (2 pages plus an indicative bibliography, clearly stating purpose, methodology and findings) or a full manuscript, must be uploaded in PDF format.
- Before uploading your PDF file please:

 a) When naming your file please use the surname of the first author in the author list followed by the first name of the first author, with names separated with an underscore as your file name (e.g. Smith_Peter.pdf, Carradine_Sarah.pdf etc.).

b) Please carefully check your file for viruses, using the most current virus-checker, before uploading it to the paper submission portal.

Please note: Complete papers will be given preference over extended abstracts.

Hard copy submission (by email, post or by fax) will not be accepted and proposals which don't comply with these instructions will be rejected.
