### **About ECHSA**

The aim of the European Congenital Heart Surgeons Association (www.echsa.org) is to advance surgery for congenital heart defects, to improve the treatment of patients with congenital heart disease in Europe, and by all means promote the research and treatment related directly or indirectly to congenital heart diseases, irrespective of the patient's race, religion, origin, wealth, or other discriminative factors. For realization of this aim, the Association carries on research of surgery for congenital heart diseases, and organizes courses, seminars and conferences for congenital heart disorders. To support these ECHSA activities, the Association receives donations, grants and sponsorships.

### **ECHSA Events**



ECHSA organizes its Annual Scientific Meeting each Spring, and may also organize additional specialized courses and seminars. Every 4 years since 2004, ECHSA has been organizing a Joint Meeting with the Congenital Heart Surgeons' Society (www.chss.org), which is ECHSA's "sister" association in the United States.

Traditionally, ECHSA Meetings were open only to the Members of the Association. However, since the 2017 Annual Meeting held in Leicester-UK onwards, all ECHSA Meetings are open to the entire congenital heart scientific community. This creates a unified platform for everyone involved in the care of patients with Congenital Heart Disease to participate and exchange experiences: cardiologists, cardiac surgeons, anesthetists, intensivists, pathologists, researchers, perfusionists, nurses and medical technicians, all are most welcome.

The Scientific program includes "best and worst" case presentations and discussions, surgical video sessions, pro and con controversy discussions, advanced clinical research presentations, specialized invited lectures, state-of-the-art symposia and industry workshops.

In response to increased demand for virtual educational programs, as the COVID pandemic remains an inhibitory factor for hosting physical events, the ECHSA set up a platform with its Secretariat, CONVIN SA, to host its events for as long as there are related restrictions. The platform, a state-of-the-art experience by itself, offered enhanced interaction opportunities and various branding and placement options. Through this platform, ECHSA has organized its 2021 and 2022 Annual Meetings in a virtual environment.

Time has now come for ECHSA to go back on track with live, face to face meetings. The 2025 ECHSA Annual Meeting will thus take place in Athens, Greece, at the Eugenides Foundation, in full physical format. ### **ECHSA Contributors**



In addition to the scientific meetings organized by ECHSA on a regular basis, the Association's contribution to the advancement of Pediatric Heart Surgery revolves around two major projects: **ECHSA Congenital Database** (ECDB) and ECHSA Multi-Institutional Studies.

ECHSA collaborates closely with the most significant scientific associations in the field of Congenital Heart Disease, with which joint meetings are frequently held:

- CHSS (Congenital Heart Surgeons' Society)
- WSPCHS (World Society for Pediatric and Congenital Heart Surgery)
- AEPC (Association for European Paediatric and Congenital Cardiology)

The official Journal of ECHSA is the **World Journal for Pediatric and Congenital Heart Surgery** (WJPCHS, http://journals.sagepub.com/home/pch), which is also the official journal of CHSS and WSPCHS.

#### **ECHSA Congenital Database**

Participation in the ECHSA Congenital Database is a major benefit of Membership. An important aim of the founding members of ECHSA was to collect data on the outcomes of Congenital Heart Surgery procedures across Europe, thereby making possible comparison of results and identification of risk factors, as well as targeting research activities. This required good quality data obtained on a large scale from numerous European congenital cardiothoracic surgery units, as well as data validation and verification. Such data collection allows risk stratification and helps define optimal surgical treatment for certain subsets of patients. It is hoped that this effort will contribute to improved early and late survival, as well as improved quality of life for surgically treated patients with Congenital Heart Disease across Europe.

The European Congenital Heart Surgeons Foundation, which was established in 1992 and obtain legal entity as the European Congenital Heart Surgeons Association in 2003, created the European Congenital Heart Defects Database (ECHDD), precursor of today's ECHSA Congenital Database (ECDB).

Today, the immediate aim of the ECDB is to collect data relating to treatment of patients with congenital heart disease, including diagnoses, risk factors, surgical and other procedures, as well as early and, eventually, long-term outcome.

The ECDB is accessed on an Institutional Level, with an annual fee required. There are currently **410 registered** centers from 86 countries.

#### **ECHSA Multi-Institutional Studies**

ECHSA Multi-Institutional Studies are planned and organized by initiatives from individual Members, and coordinated by the ECHSA Research Committee. The research plans are discussed, refined, approved, and their progress monitored at the Annual Meetings. They constitute an extremely powerful way of pooling together the experiences of a great number of centers on the treatment of important and often rare conditions. The ECHSA Multi-Institutional Studies have produced outstanding research papers, published in prestigious international peer-reviewed journals. There are always several ongoing multi-institutional studies, which, upon completion, will be presented at major scientific meetings and then submitted for publication.
