2. In order for your booking to be processed you must agree to the terms and conditions. Your place is not guaranteed until you have received email confirmation and joining instructions from Profile Productions Ltd (the PCO). 3. Without exception, all fees must be paid in full prior to the event. Any delegates arriving at the conference with their payment outstanding will be asked to settle the balance with a valid debit/credit card before entering the conference.
4. Cancellations will only be accepted if submitted by email to summit@profileproductions.co.uk and refunded as follows:
 - a. Bookings cancelled prior to 30 days before the event will be refunded, subject to a £35 administration fee.
 - b. Bookings cancelled within 30-15 days of the event will be subject to a 50% cancellation fee.
 - c. Bookings cancelled 14 days or under prior to the event will not be refunded.All cancellation fees are discretionary.
