

A Simplified Approach to SAP Indirect Tax Processing

## The ROI of modern tax software

Companies seek out tax software because they are desperate for help with a job that's simply become too complex.

Global businesses must keep track of, and consistently update, the rules and rates for various types of taxes in countries around the world. Varying local rules mean that even companies doing business in a single country face challenges. In the United States, for instance, it's not just the states that have their own rules, but individual counties, cities and towns.

Indirect tax accounting software can help ease the pain and penalties of non-compliance, delivering a sound ROI in a number of ways. For example, underpaying taxes can result in fines and "potentially massive back tax payments."<sup>1</sup> Auditors can look at two or three months of recent transactions and extrapolate penalties and back payments to determine taxes owed going back three to seven years. And while many organizations have contingency funds set aside for penalties, in inflationary times it's advantageous to reduce that reserve requirement.

### Improve visibility

High on the ROI list is visibility into tax spending, so companies can properly recover what they are owed—no mean feat given the various ways different countries account for taxes. What's more, identifying appropriate tax rates and applying these rates — automatically reduces the chance of errors, which can further increase ROI.

#### Provide timely, accurate data

Good tax reporting software will also make it possible to provide timely, accurate data to the C-suite. Perhaps a department manager wants to know how much each of their direct reports spent at restaurants last quarter. Or the CFO wants a report on any audit exposures their organization may face. It should be a simple matter to run a report that answers such questions, giving you real, live data that ensures you stay in compliance with tax laws, thereby reducing your risk.

#### Improve the employee experience

Employees who currently rely on native or outsourced ERP systems to keep track of tax rates and laws will welcome the control and automation that advanced tax software offers.

Regular updates keep the software current, and can automatically identify and enter the correct tax rate for nearly any transaction—even those for which you weren't charged but should've been.

"In the U.S., if you don't pay tax as a vendor that doesn't mean you don't owe it," Jana Zeeb, Principal Consultant, Solutions Practice, Vertex, who has also spent some 20 years as an independent sales and use tax consultant, says. "The system can do an analysis that says, 'I'm shipping to Colorado but wasn't charged local tax. Do I owe it?' If the answer is yes, it will accrue it." What's more, none of the transaction has to be entered manually, saving untold numbers of hours.

## Advanced decision-making

Automated tools such as Vertex Indirect Tax O Series offer programs that import data into SAP and run a suite of reconciliation programs.
