DQM Approaches:

DQM - at Source

Monitor and rectify data at its source, establish quality metrics, automate or manually upload data, analyze data quality, and refine at the source

DQM – DIW (Data Intelligence Workbench)

Centralized DQM remediation via DIW without source system integration. Utilizing DIW for profiling, scoring, ingestion, and analytics. Data custodians can easily make modifications and transfer data to a lake/warehouse.

DQM DIW+ Integrate

Centralized DQM remediation with DIW, integrating back to the source system, and establishing continuous application integration.

DQM(G)

Implementing DQM remediation with governance, utilizing Business Process Model and Notation (BPMN) based flows for workflow. Ensuring role and approver requirements are met to establish a governance layer before updating source data.
