Vestas had a solid Internal Control Framework, but limited visibility on control execution and overall maturity. Prior to their SAP digitization project, the business had limited resources to perform compliance reviews, and too often controls were performed late or assumed to be performed by a different function. This session will cover how Vestas utilized SAP Process Control to streamline their Financial Controls processes to overcome the initial business challenges, how they sorted the various implementation challenges and how the success of the implementation has brought opportunities to cover other business challenges not initially scoped.

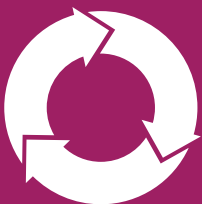
