



LUCID 2027 – Delegate Terms and Conditions

1. Registration fees include VAT at the prevailing rate, complimentary refreshments, lunch and conference materials on each day of attendance. Full registrations include Qty [1] ticket to the LUCID Conference Dinner on the evening of Monday 17 May 2027. Registration fees do not include accommodation.
2. In order for your booking to be processed you must agree to the terms and conditions. Your place is not guaranteed until you have received email confirmation. If you do not receive confirmation within 24 hours of your booking being made, you should contact the conference organisers by email at lucid@thecavalrycollective.com
3. Without exception, payment terms are 7 days or no later than Friday 14 May 2027, whichever is sooner. Any delegates arriving at the conference with their payment outstanding will be asked to provide their credit card details as a guarantee.
4. Registrations for LUCID 2027 are non-refundable, however substitutions can be made up to and including Friday 14 May 2027. If you are no longer able to attend the conference, please email the Organisers lucid@thecavalrycollective.com with full name, email and contact number of the person who is no longer able to attend and their replacement.
5. Non-attendance will not be refunded.
