Fundraising Excellence Award

For any fundraiser who, in the view of their peers, has shown excellence and best practice, over a number of years. They will have achieved high quality fundraising through either their own efforts or their vision and strategy, and will also have contributed to the development of the sector.

Nominations should be made by the Manager, Head of Fundraising, Chief Executive, Trustee or person of equivalent status, in the charity for whom the nominee works, or has recently worked. Applications cannot be made by the nominee.

Entry guidelines:

Initially, we ask that you complete the below questions, summarising the reasons you feel the fundraiser should be nominated, explaining the context and background to the individual's nomination, and will include some or all of the following information:

- Demonstration of consistent excellence and significant results in fundraising
- Demonstration of a significant increase in the charity's fundraising performance over a period of time
- Demonstration of leadership which may be by virtue of position or example
- Ability to develop good teamwork
- Ability to develop the targets of others
- A record of engaging supporters/donors
- Demonstration of their contribution to the development of the sector

Submitting your nomination:

- You may enter under multiple categories where appropriate.
- All fields are mandatory; the judging panel will not consider nomination forms with blank spaces.
- All entry forms must be received by 5pm on Friday 1st April 2022 via the awards nomination website at <https://www.scottishfundraisingconference.org.uk/ciof/awards>
- No entries will be accepted after this date.

If shortlisted, this information will be used on the Chartered Institute of Fundraisings Scottish Conference website and awards brochure. Please note that your summary may be revised for editorial purposes.

10. Supporting images

Please attach a few images, including logo(s) if appropriate, to illustrate your nomination. These will be used on our website and printed materials should your nomination be shortlisted.

The files should be in JPG, BMP or PNG formats, big enough to use in printed material, but not greater than 2MB in size. The image files should be titled with the name of your organisation plus the name of the relevant award category i.e. Fundraising Excellence.

11. Photo

Please upload a photo of your fundraiser, the files should be in JPG, or EPS formats

12. Supporting video

Please note that if your nomination is shortlisted, we may also require a short video clip telling us why your nominee deserves to win the Fundraising Excellence Award. The video is **not** required at this stage and won't have to be of professional quality, as long as we can clearly hear what you're saying.

Judging Process

A co-ordinator will receive all applications. Copies of the applications will be shared with members of the judging panel.

The panel will decide which applications will be shortlisted. The panel's decision is final. A co-ordinator will contact all applicants by email confirming the outcome of their application and where a nomination has been shortlisted, outlining the next steps.

Successful nominations for The Fundraising Excellence Award, Fundraiser of the Year Award and Volunteer Fundraiser of the Year Award may be required to participate in an informal interview with a panel member and may be required to submit a short video that will be played on the awards evening.
