### TERMS AND CONDITIONS

The terms below relate to ISCoS 2024

#### PAYMENT AND GENERAL CONDITIONS

Registrations are not valid until full payment of the fee is received. Full payment of the fees will be required before entry to the meeting is granted unless a valid proof of payment is provided.

All in-person registration fees are quoted in Euro (€) and GBP Pound Sterling (GBP, £).

Registration fee rates are based on the date of receipt, unless full payment is received before the stated deadlines, rates cannot be honoured.

To be eligible for the student, fellow, PhD Student, resident, and trainee registration rates, you must upload a written verification letter from the department/institution at the time of registration and you must be a student at the time the meeting takes place.

Early Bird payments that are outstanding more than 14 days from the Early Bird Deadline date (09 July 2024) will be amended to, and be liable for, the Standard Rate.

Those who have registered for the meeting, have not formally cancelled within the cancellation period and do not attend will be charged the full fee.

Refunds will be given at the discretion of the organising committee and will be processed after the meeting.

#### PAYMENT OF FEES

Payment of fees may be made in Euro and GBP Pound Sterling by credit card or bank transfer (transfers accepted up to 21 days ahead of the meeting). Payment by credit card will be accepted onsite in Antwerp at the Registration desk. Cash payment onsite is not possible.
