

# **TERMS AND CONDITIONS**

The terms below relate to the Association of Physicians of Great Britain & Ireland (AoPGBI) and the Association of Physicians Annual Meeting (APAM).

**PAYMENT AND GENERAL CONDITIONS** Registrations are not valid until full payment of the fee is received. Full payment of the fees will be required before entry to the meeting is granted unless valid proof of payment is provided.

All registration fees are subject to UK VAT of 20%.

Registration fee rates are based on the date of receipt, unless full payment is received before the stated deadlines, rates cannot be honoured.

No-shows at the meeting will be charged the full fee.

Refunds will be given at the discretion of the organising committee and processed after the meeting.

**PAYMENT OF FEES** Payment of fees is made in GBP by credit card or bank transfer. Only credit card payments will be accepted for onsite registration in Liverpool.

We do not store credit card details nor do we share financial details with any third party.

**CANCELLATION OR ALTERATION** Any cancellation or alteration of registration must be notified in writing from the registrant and will be subject to the following conditions:

- Before 20 March 2023: refund of fee minus £50 administrative charge.
- From 20 March 2023: no refund.
