

TERMS & CONDITIONS

The terms below relate to the Annual National Conference of Visitor Attractions 2020 (VAC 2020)

PAYMENT AND GENERAL CONDITIONS

Registrations are not valid until full payment of the fee is received. Full payment of the fees will be required before entry to the meeting is granted unless a valid proof of payment is provided.

All registration fees are quoted in GBP.

Registration fee rates are based on the date of receipt, unless full payment is received before the stated deadlines, rates cannot not be honoured.

Those who have registered for the meeting, have not formally cancelled and do not attend will be charged the full fee.

To be eligible for the unwaged/student registration rate, you must provide a written verification letter from Gov.uk or an educational department/institution at the time of registration and you must be unemployed or a full-time student at the time the conference takes place.

To be eligible for the Group registration discount, five or more people from the same organisation must be registered together at one time.

Early Bird payments that are outstanding more than 14 days from the Early Bird Deadline date (7 September 2020) will be amended to, and be liable for, the Standard Rate.

Refunds will be given at the discretion of the organising committee and will be processed after the meeting.

PAYMENT OF FEES

Payment of fees may be made in GBP by credit card or bank transfer (transfers accepted up to 15 days ahead of the meeting).

We do not store credit card details, nor do we share financial details with any 3rd parties

CANCELLATION OR ALTERATION

Any cancellation or alteration of a registration must be notified in writing by the registrant to the Secretariat and will be subject to the following conditions:

- \bullet On or before 7 September 2020: refund of fee minus £15 administrative charge.
- After 7 September 2020: no refund.

The above terms apply to all registration cancellations.
